# Proposal for restructuring PRODCOM-Nomenclature (NACE 10.20 and 10.85)

The statistics on industrial production (PRODCOM) should help the users (i.e. enterprises in the food sector) to identify the production development and composition of the food production in the different member states and the EU in total.

Since more than 20 years the output of the PRODCOM statistics for the section fish and seafood products is not of the benefit of the sector due to irrelevant grouping of fisheries products.

AIPCE-CEP has therefore proposed an amendment which complies with the structure and the basic principles of the PRODCOM list classification, namely to follow and detail further the classification of products by activity (CPA) and to maintain the correspondence with the combined nomenclature (CN).

# Algae and Seaweeds

1. With respect to Regulation 1379/2013 Article 35 the commercial name and the scientific name of products listed in Annex 1 letter e) (algae and seaweeds), have to be published in lists by each EU-member state. Does the Commission have information in which member state algae and seaweeds are published yet?
2. Furthermore, the catch or production area has to be mentioned and the fishing gear category has to be named. In the case of algae and seaweeds, the proposed gear categories do not fit with the harvesting methods of algae and seaweeds. Does the Commission have an idea how to indicate the correct category for algae and seaweeds to the consumer?

# Algae and Seaweeds

3. If algae and seaweeds are part of a food, like in a maki (sushi), or an algae preparation (salad), is then this use of the algae and seaweeds excluded from the provisions of Article 35 of Regulation 1379/2013?
