



- MAC Opinion adopted on 27 February 2019
- Commission's reply on 6 April 2019

Joint ACs Advice on EMFF funding for scientific research projects

- Letter sent on 5 December 2019
- Supported by BSAC, LDAC, MAC, NSAC, NWWAC, PELAC, and SWWAC
- Request that capital funding is provided under the EMFF specifically to ACs to carry out well defined costed projects of direct relevance to the ACs to adequately fulfil their advisory role under the CFP

EMFF – STATE OF PLAY

European Parliament

- Report adopted: 4 April 2019)
- Rapporteur: Francisco José Millán Mon (EPP, ES)
- Decision to open trilogues: 12 November 2019

Council

- Partial General Approach: 18 June 2019
- Special Council on Multiannual Financial Framework (MFF): 20 February 2020

Trilogues

- >19 November 2019 and 10 December 2019
- ► Next: 4 March and 30 March 2020


