Allocation from EFMRA for Poland:

- ▶ The allocation granted to Poland from the European Maritime, Fisheries and Aquaculture Fund is combined with two sources national and UE budget:

70% (EU funds) and 30% (state budget)

- ▶ Allocation from EMFAF - EUR 512,387,953.00
- ▶ National budget - EUR 219 594 837
- ▶ **Total - EUR 731,982,790.00**

State of play

- ▶ On 5th May 2022, the national legislative procedure approving the draft program was completed - it was adopted by the Council of Ministers.
- ▶ The draft program was introduced into the SFC2021 IT system and submitted to the European Commission on 19th May 2022.

Procedure of program approval by the European Commission

- ▶ Defined in art. 23 of the European Parliament and Council Regulation 2021/1060 (CPR)
- ▶ Formal transfer of the program via SFC2021
- ▶ The Commission assesses the program and its compliance with the CPR and the EFMRA Regulation and its consistency with the Partnership Agreement.
- ▶ The Commission may submit its comments within 3 months from the date of submission of the program by MS .
- ▶ The Commission shall adopt a decision by means of an implementing act approving the programme no later than 5 months after the date of the first submission of the programme by the Member State.

Stages of work on the preparation of the program (national legislative procedure).

- ▶ Internal arrangements
- ▶ Submission to the list of legislative works of the Council of Ministers
- ▶ External arrangements and public consultations
- ▶ European Affairs Committee
- ▶ Standing Committee of the Council of Ministers
- ▶ Council of Ministers

Public hearing

In addition to the legislative path:

- ▶ The program draft was subject to a public hearing (October 6, 2021) - previously, the draft program draft was made available on the website www.minrol.gov.pl . Over 200 participants of the online meeting had the opportunity to express their opinion .

Consultation of the program design:

- ▶ public consultations lasted from 18th February to 15th March 2022.
- ▶ On the website of the Ministry of Agriculture and Rural Development (<https://www.gov.pl/web/rolnictwo/projekt-programu-fundusze-europejskie-dla-rybarzenia--poczatek-konsultacji>), a draft resolution (with draft programme) has been published along with an invitation of the minister to submit comments using the form provided there.
- ▶ Moreover, the information on the launch of public consultations was provided directly to 116 entities, including enterprises and organizations operating in the fisheries sector as well as non-governmental organizations.
- ▶ 740 comments were submitted to the draft as part of public consultations.

Principles of providing support in the financial perspective 2021-2027

- ▶ similar to the rules in force in the 2014-2020 financial perspective.
- ▶ Detailed rules of support will be specified in the normative acts which are currently developed in the Ministry of Agriculture - the Implementation Act and implementing regulations.
- ▶ Support will be granted at the request of the beneficiary in the form of a subsidy or compensation. In some cases, it will be possible to use simplified costs.
- ▶ The aid will be granted to the beneficiaries on the basis of the aid intensity specified in Annex III to the EFMRA Regulation.
- ▶ Grant applications will be submitted via electronic form using the Central ICT System operated by the Ministry of Funds and Regional Policy.
