# ACTION POINTS (20 SEPTEMBER 2022)

#### **Biodiversity in Areas Beyond National Jurisdiction:**

- Topic to be addressed, from a trade perspective, by Working Group 2, in the context of the new Focus Group on Trade, while keeping track of developments in LDAC
  - Topic moved to Working Group 2

#### **Product Environmental Footprint Category Rules:**

- Focus Group on PEFCR for Marine Fish to be temporary suspended until new developments, such as the second public consultation on the draft PEFCR
- Under the draft agenda of the next meeting, invitation to be sent to DG ENV for an exchange of views
  - MARE A4 suggested not to include the exchange, since the PEFCR was put on hold

#### **Sustainable Food System Framework:**

- Secretariat to informally consult the intervening members about the redrafting of point 1) of section 4 of the draft advice
- Remaining sections of the draft text to be considered under a written procedure under Working Group 3
  - Advice adopted: 13 December 2022

#### **Empowering the Consumer for the Green Transition:**

- Secretariat to informally consult the intervening members about the redrafting of footnote 14 of the draft advice
- Following the redrafting of footnote 14, draft advice to be put forward to the Executive Committee for potential approval via urgent written procedure
  - Advice adopted: 7 October 2022



## ANIMAL WELFARE

#### Presentation on revision of EU legislation

- Denis Simonin (SANTE G<sub>3</sub>)
- Roadmap: 6 July 24 August 2021
- Public Consultation: 15 October 2021 21 January 2022
- Planned adoption: Q3 2023
- MAC Advice: 30 March 2022
  - Coherence with other initiatives affecting labelling & consumer information
  - Support EU fish farmers move towards high animal welfare standards
  - Undertake studies to understand fish welfare + impact of existing labelling schemes
  - Imports: avoid complex control arrangements & administrative burden + ensure respect of WTO rules
  - Labelling: Common minimum requirements for all animal claims made on the EU market

## **FOOD SECURITY**

- ➤ Presentation about launch of study on "mapping the risks and vulnerabilities in the EU food supply chain"
  - Daniele Bertolozzi (Ecorys)
  - MAC Advice: 28 May 2021 (Contingency Plan for Ensuring Food Supply & Security)
    - Creation of permanent forum + guidelines / recommendations for EU coordination
    - Maintain all parts of the chain operational
    - Raw material: risks of climate change (oxygen levels in seas, warming of oceans)
    - Anthropogenic hazards: overfishing, pollution
    - Geopolitical: protectionism, trade sanctions
    - Very low self-sufficiency rate for fisheries and aquaculture products
    - Role of dominant actors (e.g.; China): hubs for container traffic, processing countries with significant capacity and exponentially growing domestic demand
