Under the Work Programme of Year 7, the MAC committed to provide suggestions to DG MARE on topics (price structure analyses and thematic analyses). On 17 October 2022, the MAC adopted advice suggesting a study on the challenges of aquaculture products in food outlets. In their reply, DG MARE agreed to the study, but requested a meeting to discuss the scope and the tasks. On 3 February 2023, the MAC adopted advice suggesting studies for the 2023 Work Programme of EUMOFA.
