    - Additional knowledge provided on potential challenges and opportunities offered by cultured meat and cultured seafood to reduced greenhouse gas emissions, air, water and soil pollution, resource depletion and impact on ecosystems, generation of wastes, and on human health

  - Option 3 Increasing compliance (strengthened due diligence)
    - MSC
  - Option 4 Elimination of least sustainable operations/products by setting minimum sustainability requirements based on "do no harm principle" (4A only EU / 4B EU + imports)
    - Option 4A Only products produced in the EU
    - Option 4B Products produced and placed in the EU
      - FEDEPESCA, EAPO
  - Option 5 Combination of options 2, 3 and 4
    - Combination of 3 & 4B Oceana, Good Fish, EJF, Europêche
    - Combination of 2, 3, & 4B ClientEarth

- Option 1 Voluntary
- Option 2 Sustainability labelling provisions developed in sector specific legislation
- Option 3 New EU framework for sustainability labelling (general framework + voluntary label)
  - Option 3A Only for products of higher sustainability performance
  - Option 3B All food products
  - MSC, FEAP, EuroCommerce, ANFACO-CECOPESCA
- Option 5 New EU framework for sustainability labelling (general framework + mandatory label
  - Option 4A For all EU food products
  - Option 4B For all EU and imported food products
    - · Oceana, Good Fish, Europêche (ranking system), FEDEPESCA, EAPO

- 3) Policy options for push measures Sustainable public procurement:
  - Option o Do nothing
  - Option 1 Voluntary
  - Option 2 General provisions and requirements aiming to raise awareness and improve skills and knowledge of sustainable public procurement, capacity building and support authorities in using public procurement strategically
    - MSC, FEAP, EAPO
  - Option 3 Mandatory general and specific requirements
    - WWF

  - Article 4 of Regulation 2015/242:

"The Advisory Council shall designate, by consensus, a chairperson and at least one vice-chairperson. The chairperson may originate from outside the membership of the Advisory Council. In case the chairperson is designated amongst representatives of member organisations, at least one of the vice-chairpersons shall be designated amongst members of the category of sector organisations and other interest groups referred to in Article 2 to which the chairperson does not belong. This principle shall also apply, where possible, to working groups' chairpersons."
