FISHERS OF THE FUTURE

- Exchange of views about the survey on challenges and drivers, profiles of today's fishers, and scenario planning workshops
 - Survey on challenges and drivers (7 20 February 2024)
 - Predatory species, marine resource scarcity, ecosystem condition, climate change
 - Interactions & conflicts with other coastal users, new governing systems, rethinking trust in institutions, overdevelopment
 - Inflation, pressure on the middle class, changing market demand & consumption patterns, vessel costs, alternative income opportunities & recruitment challenges
 - Rising significance of migration, maritime security, expanding influence of East & South, geopolitical conflicts, relations with neighbouring countries
 - Lack of infrastructure, automation & use of AI, quality of scientific data, technological change
 - Continuing urbanisation, fisher demographics, changing nature of work, entrenched inequalities, growing mental health pressures
