Under the annual Work Programme, the MAC committed to providing advice on the work programme of EUMOFA, including suggestions of case studies and talks. Consideration	Sustainability Criteria	At the request of DG MARE, STECF has been developing sustainability criteria and indicators for fishery and aquaculture products. The latest report focused on three fisheries-specific indicators (impact on seabed, impact on targeted stocks, impact on sensitive species), which will be integrated into a voluntary tool. At the 17 September 2024 meeting, there was agreement on a draft advice on the development of the fishery sustainability indicators, but the Executive Committee concluded that further worked was needed. A questionnaire was circulated to gather feedback for a new proposal of draft advice. Additionally, MARE A4 established a group to test the new tool.
