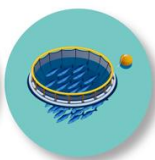

Information + Decision	Animals Transport	In December 2023, the European Commission published a legislative proposal amending the rules on the protection of animals during transport and related operations. The regulation will cover the transport of aquatic animals (fish, cephalopods and decapods).	Presentation of the legislative proposal by Commission representative. Information	Food Labelling	Last year, the European Court of Auditors published a special report, which found that food labelling in the EU can help consumers make better-informed decisions when purchasing food, but that there are notable gaps in the EU legal framework as well as weaknesses in the monitoring, reporting, control systems, and sanctions. The report touches on information on origin/provenance, nutrition information, plant-based products, health claims, sustainability, and private certification schemes/labels. The report does not specifically address the common market organisation of fishery and aquaculture products.
