- ➤ Presentation of the Commission Delegated Regulation for fishery products frozen in brine on board vessels
 - Paolo Caricato (SANTE G₅)
 - Adoption of the Delegated Regulation by COM: 18 July 2025
 - Amendment to hygiene rules for animal products
 - Whole fish initially frozen in brine on board vessels at a temperature of not more than -9°C, even if it is subsequently frozen at -18°C, must be exclusively destined for canning or for cooking in establishments carrying out processing operations


