Information	Labelling of fishery and aquaculture products	FEAP expressed concern over the use, in international markets, particularly in Asian and Middle Eastern countries, of the term “seabass” when referring to barramundi (<i>Lates calcarifer</i>). In their view, this practice could mislead consumers and undermine the reputation of European seabass (<i>Dicentrarchus labrax</i>). Therefore, FEAP would like the Commission to encourage competent authorities, retailers, and industry stakeholders in third countries to ensure that fishery and aquaculture products are clearly identified by their correct common and scientific names. Information + Decision	Common Market Organisation for Agricultural Products	On 16 July 2025, the European Commission adopted a legislative proposal to amend the Common Market Organisation for Agricultural Products Regulation. The proposal introduces restrictions to the use of “meat-related terms”(e.g., “loin”), which could impact the market of fishery and aquaculture products. The European Parliament’s mandate aims for the inclusion of further designations (e.g., “steak”, “escalope”, “sausage”, “burger”) as well as exclusion of cell-based products. Information	Food Fraud	In 2025, the European Commission launched the “Goldfish” coordinated action to combat short-weighting of fishery and aquaculture products in the EU market. “Short-weighting” consists of “when processors misrepresent the weight of a seafood product by including the weight gained through practices such as over glazing, soaking, and breeding to the net weight of the seafood”. Information	Food Labelling	In November 2024, SAFE published a report on enhancing transparency in food products, which particularly focused on the use of the term “natural”. The results of the survey indicated that there is a broad range of interpretations among EU consumers. The report calls for improved transparency and clarity in food labelling. Consideration	Competitiveness	Under the Competitiveness Compass for the EU, the European Commission identified simplification as a priority. The Compass sets a target of cutting the administrative burden by at least 25% for firms and by at least 35% for SMEs. At the 18 September 2025 meeting of the Executive Committee, DG MARE delivered a presentation on their initiatives to reach the targets. A questionnaire was circulated from 3 to 17 October 2025 to collect feedback from the members on the initiatives.
