The report combines DNA analysis with EU trade data on inadequately labelled products in Italy and Belgium. According to the report, there is significant opacity in the market. Information	Contaminants	On 9 September 2025, EEB published a report on PFAs contamination in Europe's water and fish. Their report covers analyses monitoring data from Austria, France, Germany, Italy, Poland, Spain, and Sweden. Later that month, the Council and the European Parliament reached a provisional agreement on the update the priority substances in surface and ground waters. Information + Decision	Nutrition	On 29 October 2025, following a symposium, Interfish published a decalogue on fish consumption, health and sustainability. The document, via scientific evidence, aims to provide ten reasons for the regular consumption of fishery products.
